Centre A responsibilities

AIMS undertakes to provide Phase 1 of the joint Programme. During Phase 1 of the Programme AIMS will provide a comprehensive training programme, which will include theory and practical classes, project work, group exercises and discussions consistent with the Programme.

Phase 1 of the Programme provides year 1 of the HND programme, and contains all assessment and examinations as required by the current SQA QA requirements. It is the responsibility of AIMS to assess students using formative assessments, and guidance will be provided by STC to assist AIMS staff to ensure the appropriate range and standard of assessment is reached. AIMS staff will prepare, mark and moderate all formative assignments undertaken at their centre.

Centre B responsibilities

South Tyneside College (STC) are the lead centre, and undertake the full QA responsibilities for the HND programme.


STC will provide a training programme to enable students to gain the final SQA HND award. STC will undertake all formal summative assessments of the HNC and HND elements, to ensure compliance with current MCA certification requirements, and will retain student assessment evidence for External SQA validation.

STC will register all students with SQA and pay the appropriate registration fee on their behalf.

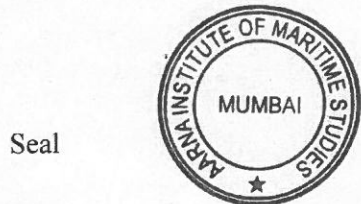
Annual QA visits are undertaken by STC to AIMS, and these reports are available for MCA / SQA monitoring on request.
